

The Blueprint for Maryland's Future changes the funding formulas for all public schools.

- **Charter schools will be harmed by proposed formula, which only gives schools 75% of the Per Pupil Allocation (PPA) for operations.**
 - **♦** What does this mean?
 - ➤ Decrease of approx. \$500,000 starting SY24-25 (June 30, 2024-July 1, 2025); reduction will have devastating impact on FCCS' budget.
 - **Why does that matter?**
 - > FCCS uses the PPA to employ teachers, purchase educational materials, pay for building operations, and support scholars.



Without a change in funding formula, FCCS is projected to close its doors within the next 5 years. We cannot sustain our operating costs with a funding reduction.

 - ➤ Ask that the BOE/FCPS re-consider funding formula by either adjusting the 75% allocation or pausing implementation until further consideration is given to public charter schools.
- **Personally invite BOE Members to visit FCCS, so they can experience the joy of our school firsthand.**







Operations

SY 2023 Actuals	SY 2024 Budget
\$808,852	\$848,834

FCCS operations budget includes allocations for custodial services including custodial supplies, facilities rent, electricity, natural gas / propane, telecommunications, security, technology services and all other costs associated with maintaining operations.



Maintenance

SY 2023 Actuals	SY 2024 Budget
\$115,654	\$112,815

FCCS maintenance budget includes allocations for the upkeep of the grounds, estimates for facilities maintenance repairs and maintenance supplies.

Financial Analysis



- The PPA is FCCS' source of funding for facilities.
- As is the case for all charter schools, costs associated with facilities' maintenance and operations are paid from funds that would otherwise go directly into the classroom.
- In the current Blueprint Funding proposal, FCPS:
 - elected to withhold the maximum allowed from schools of 25%.
 - o disregarded the transportation funding ruling from MD's highest court.
 - has not provided a clear breakdown of the line items to which the 25% withholding would be allocated.
- 25% withholding may contain:
 - o admin costs exceeding the 2% cap; excess should be added back to the funding calculation under the charter funding law.
 - o contains maintenance and potentially other service costs on behalf of schools that need to be added back to the funding calculation per the charter law.
- Based on what we know so far, the scope of the cut is approximately the cost of FCCS's facility rent.
